## Back Injuries



Unfortunately, the reality is that most of us will experience some form of back pain during our lives. And while back pain is often no more than a strained muscle or ligament that gets better within a few days or weeks, sometimes back pain can be a serious and debilitating condition that causes chronic pain, making it impossible for a person to work or even perform everyday tasks.

Certain occupations such as nursing, construction or factory work can take a tremendous toll on your back, but even standard office work can lead to back pain or make it worse.

### So, What are Some Common Causes of Back Injuries at Work?

- **Force** – Lifting or moving heavy objects, which can exert too much force on your back, is a leading cause of injury.
- **Repetition** – Repetitive movements, especially if you're in an awkward position, can cause a back injury.
- **Posture** – There's a reason your mother always told you to stand up straight!
- **Stress** – High stress at work can cause muscle tension which can lead to back pain or exacerbate existing pain.

The good news is that there are some things you can do to lessen your risk of suffering a back injury, including getting regular physical activity, modifying repetitive tasks (for instance, consider using a headset if you're on the phone all day), lifting properly and removing any hazards around your workspace that could lead to a fall. 
## Ingredients

- 10 boneless chicken pieces (I use chicken tenders)
- 2 eggs
- 1 cup breadcrumbs
- 1/2 cup grated parmesan cheese
- 1/2 cup honey-Dijon mustard
- Salt/pepper to taste
- 4 tablespoons butter, or olive oil, divided

## Preparation

1. Preheat oven to 400°F
2. Whisk mustard and eggs together

3. Mix breadcrumbs with cheese
4. Grease 9x13 baking dish with 2 tablespoons butter or olive oil
5. Dip chicken in egg/mustard mixture, then in breadcrumb/cheese mix.
6. Place breaded chicken in buttered pan, drizzle remaining butter or olive oil over chicken.
7. Bake for 10 to 15 minutes, turning once. ■

## Frequently Asked Questions from Our Clients

**Q: How long will it take to get a decision on my Social Security Disability claim?**

**A:** There is no hard and fast rule as to how long Social Security will take to evaluate your claim. Keep in mind that for most claims, there are several steps. Some disability claims, such as those involving terminal illnesses or conditions, are processed in an expedited fashion in only one step, and can result in a decision within 30 days in many cases. Social Security strives to process most disability claims within 120 days or less. However, there are instances in which a decision on a claim will take longer. Very often, a case can take a couple of years from start to finish. ■

### *Busy Christmas at the Keefes*






This will be an unusually busy summer, even for us, but so wonderful! ■




